**CALL TO ORDER**

Vice Chairman Gomez called the March 27, 2014, public meeting of the James River Water Authority (JRWA) Board of Directors to order at 5:36 pm.

Mr. Nichols welcomed the members of the public attending the meeting provide a brief overview of the purpose of the public meeting. He also introduced Board members, staff, and support personnel present.

**Discussion – Permitting Process**

Mr. Hines reviewed the process to relocate and reissue the James River withdrawal permit from the vicinity of Bremo Bluff to an area near the Town of Columbia. Using diagrams, charts, and GIS images, Mr. Hines and Mr. Saunders explained planning as it pertains to the proposed JRWA intake structure and pipeline pathway.

They also answered questions regarding the process and the project with regard to siting and potential visual, noise, historical artifacts/structures, and James River impacts.

2. Timmons to submit Decibel (db) level of primary motors for all to consider
3. Timmons to enclose pump motor station

Mr. Dubé and Mr. Nichols also addressed questions from the public regarding the history of the JRWA and Fluvanna and Louisa plans for water usage.
