Announcements and Updates

- **Fluvanna County Affordable Senior Housing Project Timeline**
 - Apr 1, 2016 – DHCD application submitted for funding assistance for Affordable Senior Housing in Fluvanna
 - May 20, 2016 – Received DHCD letter reserving funds and identifying the initial tasks to be complete by July 29
 - Jun 29, 2016 – Public meeting and 1st Management Team meeting
 - Jul 2016 – Community Surveys advertised and results collected
 - Jul 26, 2016 – 2nd Management Team meeting
 - Aug 3, 2016 – Submission of initial tasks and final documentation to DHCD
- ***Oct 3, 2016 – Received confirmation letter from DHCD that they have acknowledged an acceptable level of interest in need of developing plans for this proposed project***
- **Future Project Timeline/Steps**
 - Nov 2016 – Facilitated Planning Strategy Session with DHCD Representative to begin work on the Planning Grant Proposal
 - Dec 2016 – Submission of Planning Grant Proposal
 - Jan 2017 – DHCD approval of Planning Grant Proposals
- **Keeping in mind...**
 - Activities under the Planning Grant are intended to position the County to apply to DHCD for a Community Improvement Grant (CIG) up to \$700,000 in March 2017 with grant awards being announced in September 2017.
 - If awarded, funds would be used for design costs and site improvements.
 - PHA would enter into a joint venture with JABA and could possibly break ground in 2018.



Vehicle License Fees

- **Based on State Code 46.2-694, our current fees are:**
 - Cars/trucks \$33.00
 - Motorcycles \$18.00
 - Trailers None
- **License Fees are not currently assessed on Trailers or Semitrailers**
- **Current DMV Rates for Trailers**
 - 0 - 1,500 lbs (per year) \$18.00
 - 1,501 - 4,000 lbs (per year) \$28.50
 - 4,001 or more lbs (per year) \$40.00
 - Single weight (travel trailer for living quarters) \$29.50
- **If a Trailer base fee of \$18.00 was adopted:**
 - Current Number - 4,870
 - **Potential Revenue - \$87,660 (annual)**
