BUDGET REVIEW – AGENCY PRESENTATIONS

Fire and Rescue Association – John Lye, President, and Debbie Smith, Emergency Management Coordinator presented an overview of the budget requests for the Fluvanna Fire and Rescue Association. Highlights included an explanation of needed new equipment and potential shortfalls.

Cooperative Extension – Kim Mayo, Extension Agent presented the FY19 Cooperative Extension budget. 2017 Highlights included:

- 2 New STEM programs offered
- 1720 Youth Reached
- 10 4-H Clubs
- 167 Volunteers (68 Youth)
- 254% increase in 4-H enrollment since 2009

FY19 New Position Requested - 4-H Program Assistant, Part-time 20hrs/week

- Duties:
 - Assist with planning, implementing, and evaluating youth programs.
 - Manage 4-H Enrollment
 - Other duties as assigned
- Managed by VCE
 - Billed quarterly
 - No additional county responsibilities
 - Existing 4-H Program Assistant positions in Buckingham, Albemarle, Louisa, Orange (Nelson in progress).
- Cost for FY19 \$16,323

Social Services – Kim Mabe, Director presented the FY19 Social Services Budget Request.

 $\it Library - Cyndi$ Hoffman, Director presented an overview of FY18 and the FY19 Budget request. Highlights of the presentation:

- Circulation We checked out 226,992 items and downloaded 7,861 eBooks, audios & streaming videos (including picture books in sign language)
- Collection 77,365 items in the Library and 20,744 eBooks, audios, & streaming videos; Rosetta Stone database which offers instruction for 30 languages
- Borrowers 13,707 active users
- Internet Users 14,985 computer lab and WiFi users
- Summer Reading (15 weeks) Over 800 kids & teens read over 8,000 books
- Other Programs/Volunteers

- o Over 6,900 adults, teens and kids attended 278 Library programs
- Over 22,044 people attended 833 community programs.
- Utilized 3,265 hours of volunteers to help with programs and more around the Library
- Funding and State Library Aid The State Library requires local operating expenditures of at least 50% of the median statewide local operating expenditures per capita. Fluvanna has a Five-year plan in place with the State to achieve this level of funding by FY2020 (\$300,307) or lose State Aid.
- 2016 Fluvanna is \$12.66 per capita ranked 84th out of 92 libraries
- 2015 Fluvanna is \$11.56 per capita ranked 84th out of 91 libraries
