- Nadine Armstrong, spoke in support of Columbia Baptist Church's request to have the cemetery returned to the church. She also informed the Board of the effort of finding the names of all who are buried there.
- Bruce Bowling, Pastor of Columbia Baptist Church, commented on the Church's effort to clean the cemetery, and offered continuing upkeep to be done by the church should the Board give the cemetery to Columbia Baptist Church.

7 - ACTION MATTERS

County participation in Virginia Opioid Settlement (2nd settlement) – Frederick W. Payne, County Attorney County Participation in Virginia Opioid 1st Settlement

- In October 2021, several entities filed claims nationally against three distributors and one manufacturer of opioid pharmaceuticals, which claims were participated in by the Commonwealth and approximately 80 of its localities at that time.
- These claims have been tentatively settled by the agreement of all participating parties to accept a monetary settlement and, in return, releasing all claims to which they may be entitled against the settling distributors and manufacturer.
- The amount of the settlement is approximately \$26 billion nationally, of which approximately \$530 million will be paid over time to the Commonwealth, including the Opioid Abatement Fund, and the participating Virginia localities.
- It is contemplated that approximately 30% of the total will accrue to the Commonwealth's participating localities.
- The MOU to approve the negotiated settlement was signed by the Attorney General on behalf of the Commonwealth in August of 2021.
- On November 17, 2021, the County approved by resolution to participate in the Virginia Opioid 1st Settlement.
- In addition, the Commonwealth has created the Opioid Abatement Authority (OAA) for administrative oversight during this time.

County Participation in Virginia Opioid 2nd Settlement

- In January 2023, several entities have filed claims nationally against two manufacturers of opioid pharmaceuticals and three large retail pharmacies, which claims have been participated in by the Commonwealth and approximately 135 of its localities (Counties and Cities).
- These claims have been tentatively settled by the agreement of all participating parties to accept a
 monetary settlement and, in return, releasing all claims to which they may be entitled against the
 settling distributors and manufacturer.
- The amount of the settlement is approximately \$20 billion nationally, with approximately \$17 billion of
 this amount will be used by participating states and subdivisions to remediate and abate the impacts of
 the opioid crisis.

- The precise amounts to accrue to each locality cannot be calculated until all participating localities have filed the necessary documents to participate.
- A presentation on eligible uses and proposed uses for Fluvanna County will be brought back at a later time.

VDOT Quarterly Report – Scott Thornton, Residency Administrator/Louisa Residency

Free Hill Cemetery – Tricia Johnson, Fluvanna County Historical Society

Tricia Johnson with the Fluvanna County Historical Society gave an overview of the historical ownership of the Free Hill Cemetery in the former Town of Columbia. The Free Hill Cemetery was owned by the Town of Columbia and was acquired by Fluvanna County when the Town was dissolved in 2016.

- At the request of Columbia Baptist Church members and other descendants of people buried at Free Hill, the Fluvanna Historical Society (FHS) plans to submit an application for grant funding for GPR work on the entire cemetery, as well as fencing, the installation of a congregate memorial listing the names of people buried there in unmarked graves, and historical interpretive signage.
- The FHS requests deeding the parcel lots 37, 38, 53 & 54, as well as the roadbeds that form the northern and eastern boundaries of the cemetery, to Columbia Baptist Church, and A letter stating the county's intent is a requirement of a grant application, due March 15.
- The Board directed staff to begin the process of drafting a letter of intent to give the Free Hill Cemetery to the Columbia Baptist Church via the Fluvanna Historical Society.
