- Benefits of adding "Infield Mix" on Ball Fields
 - New soil content helps prevent compaction during dry times
 - Material is more workable and will not need much if any other fast drying agents spread
 - Field conditioner in soil helps with moisture absorption,
 soil absorbency and water management
 - Eliminates the need to manually work conditioner into existing infield mix
 - Saves money, staff time, and increases playability for all groups
