Mr. Ullenbruch moved to deny ZMP 12:02, a request to amend the Fluvanna County Zoning Map with respect to approximately 222.03 acres of Tax Map 30, Section A, Parcel 110 and 10 acres of Tax Map 19, Section A, Parcel 39C, for an aggregate of 232.03 acres, to conditionally rezone the same from R-3, Residential, Planned Community (conditional) to Planned Unit Development (PUD). Mr. Weaver seconded. The motion carried, with a vote of 3-2. AYES: Ullenbruch, Sheridan, and Weaver. NAYS: O'Brien and Booker. ABSENT: None.
