State Code

Bldg Plan

- Requested to build a new facility on County property
- Appears that County cannot make donations (including free rent) to any sectarian organization, except within the narrow and specific exceptions listed in the state statute § 15.2-953.
- If the Society is to occupy County property, it can only be done in the context of surplus property being leased, etc., at fair market value.

- **Improvements:**

– 960 sq ft Storage Bldg at \$25/sq ft = \$24,000

- **Land:**

– ~¼ acre at \$6,000/acre = \$1,500

- **Total estimated fair market value** \$25,500
