RESOLUTION

NOW, THEREFORE BE IT RESOLVED that the Fluvanna County Board of Supervisors hereby authorizes the county attorney, in conjunction with the attorney for the Town of Columbia, to petition the Fluvanna County Circuit Court to order a special election for a referendum on the question of whether the town charter of the Town of Columbia shall be annulled and repealed, in accordance with Virginia Code Sections 15.2-3700, *ff.*, and 24.2-684.
