- Fluvanna County conducted a reassessment this year, with new assessment values to be effective Jan 1, 2015. Overall impact is a 2% increase in total taxable value for 2015. Assessor Hearings and subsequent Board of Equalization (BOE) hearings will impact those numbers, but not significantly.

*Mr. O'Brien*: Reminded the Board that next Thursday (October 23, 2014) is World Polio Day; Rotary Foundation is involved in Polio Eradication and hopes to raise awareness and eradicate polio worldwide.

Mrs. Booker: Interagency Council on Oct 3. Grant writing workshop with Shelley Murphy. Youth Advisory Council—engaging middle school students. Today met with School Superintendent, to discuss bringing more afterschool activities to middle school aged students.

#### **ACTION MATTERS**

FY14 Fluvanna County Public Schools Supplemental Funding Request – Eric Dahl, Finance Director. Mr. Dahl presented a proposal for supplemental funding for \$97,830 for FY14. Mr. Dahl reported that even though the Fluvanna County Public Schools spent less than was appropriated, the revenues were also lower than forecast. Actual expenditures were \$34,873,482 with actual revenues of \$34,775,652 for a shortfall of \$97,830. While local revenues were up for FY14, state and federal revenues were lower than anticipated.

Mr. Weaver asked for clarification on Average Daily Membership (ADM) statistics and the number of students enrolled from year-to-year. Mr. Dahl deferred the question to Mr. Edward Breslauer, Finance Director for Fluvanna County Public Schools. Mr. Breslauer reviewed a presentation given at the School Board meeting conducted earlier in the month. Mr. Breslauer took a few moments to explain the State template for funding that is linked to ADM and how changes to that ADM affect the amount of funding. Chair Booker noted that predicting ADM is a moving target and in a downward trending environment, ADM is a very difficult number to predict. Superintendent Keller reiterated the difficulty involved in predicting ADM and subsequent requests for funding and gave the Board an overview of what other schools in the state are facing.

#### **MOTION:**

Mr. O'Brien moved that the Board of Supervisors approve a supplemental appropriation in the amount of \$97,830 for the FY14 Fluvanna County Public Schools budget, with funding to come from the Fluvanna County General Fund. Mr. Sheridan seconded and the motion passed 4-0. AYES: Booker, O'Brien, Sheridan, Weaver. NAYS: None. ABSENT: Ullenbruch.

FY14 Loan to the Fork Union Sanitary District (FUSD) - Eric Dahl, Finance Director. Mr. Dahl presented a proposal from the Fork Union Sanitary District (FUSD) for an additional \$39,000 loan citing an insufficiency of revenue for FY14. Mr. Dahl gave a brief overview of FUSD cash flow, and loan history from the County to FUSD (currently \$109,00 with this request), noting that the previous loans have not been repaid. However, a rate increase was approved, effective August 1, 2014. Mr. Steve Nichols indicated that an update would be reported in January 2015 to evaluate the effect of the rate increase. After brief discussion among Supervisors, a motion was made.

#### **MOTION:**

Mr. O'Brien moved that the Board of Supervisors approve a \$39,000 loan from the Fluvanna County General Fund to Fork Union Sanitary District, effective June 30, 2014. Mr. Sheridan seconded and the motion passed with a vote of 4-0. AYES: Booker, O'Brien, Sheridan, Weaver. NAYS: None. ABSENT: Ullenbruch.

Dr. Meyers presented a summary of the Strategic Initiatives updates: Market Fluvanna contests—I Love Fluvanna & Business Promo Challenge; the Piedmont group of counties working on a Wine Trail; Pleasant Grove as a background for a history of wine growing in the area; Business and Tourism Guide. Staff has been providing information regarding Core Services—a report will be forthcoming near the end of the year. Comprehensive Plan Community update meetings shifted from September 2014 to October 2014. Master Water and Sewer Plan in the works; company has been selected and plans are being reviewed.
