A. Region 10: Background: A proposed bond modification through the Fluvanna County Economic Development Authority. As background, in 2013, the Authority issued its Revenue Bonds (Region Ten Community Services Board, Inc. Project),

Series 2013A and Series 2013B, in an original principal amount of \$5,857,000. The principal financing document consisted of a Bond Purchase and Financing Agreement among the Authority, Region Ten, and Union Bank. In light of last year's Tax Act, Region 10 and the Bank hope to amend the Bond and the Bond Purchase and Financing Agreement to change the yield protection provisions, but as the Authority is a party to this document, the Authority is a necessary party to approve the amendment.

Dan Nunziato stated his motion- "I move the Economic Development Authority of Fluvanna County, Virginia approve the resolution entitled "Resolution of the Economic Development Authority of Fluvanna County, approving an amendment to the Authority's Revenue Bonds (Region Ten Community Services Board, Inc. Project), Series 2013A and Series 2013B".
