There is no cost to the business or the customer. There is a charge of \$3.95/month and County would seed the reward fund. The County would set the percentage of the reward amount, and has the flexibility to change it or restrict it to a specific business category or time frame. Rewards must be redeemed within three months. County sets up the profile. Customer could have separate "wallets" for different localities. Bluedot helps with marketing. Most communities start with \$5,000-10,000 seed money. Board of Supervisors would have to approve funding.
