#### **CALL TO ORDER**

#### **ADOPTION OF AGENDA**

#### **DISCUSSION /INFORMATION ITEMS**

Accounts Update—Linda Lenherr, provided an update of accounts:

- Higher bank balances as related to tax collection
- Mr. Garcia noted a net gain of \$50,000 in interest after fees/expenses/realized losses since inception of VIP for the County.

Investment Strategy—Multi-Bank Securities: E-Connect Direct—Eric Dahl, Deputy County Administrator & Finance Director, presented an update on Multi-Bank securities, providing information from Virginia-based references. Mrs. Lenherr noted positive user feedback from VACo. Mr. Nichols discussed moving more money to VIP; Mr. Garcia recommented investing funds for greater than 3 years in Multi-Bank long term, and recommending using the \$1.5 million formerly in BB&T to open an account with Multi-Bank.

#### MOTION

Mr. Garcia moved to make \$1.5 million available to invest with E-Connect Direct. Mrs. Lenherr offered second and motion passed 3-0. AYE: Sheridan, Lenherr, Garcia. NAY: None. ABSENT: None.

#### **MOTION**

Mr. Garcia moved to authorize the County to open an account with Multi-Bank Securities. Mrs. Lenherr seconded and the motion passed 3-0. AYE: Sheridan, Lenherr, Garcia. NAY: None. ABSENT: None.

*Discussion of Future Meetings*—Chair Sheridan discussed moving the meetings to the first Tuesday of each month beginning in September. The next meeting was set for September 6, 2016.
