The following are for clarification purposes:

1. Please remember that "Bidders shall submit any questions in writing. Written responses, including the questions, will be posted with the IFB. Questions will not be accepted after July 15, 2020, at 10 a.m. eastern standard time." See Section 4(A)(ii) of the IFB, and also Section 2(C).
2. The County will not pre-approve any "Optional Alternate", but such "Optional Alternate" may be submitted by a Bidder per Section 3(J) of the IFB 2020-01: "OPTIONAL ALTERNATE: The Contractor may submit a Bid to install a prefabricated building or install onsite a fabricated building in lieu of the Building illustrated in the Building Plans; either optional bid must (i) meet or exceed the specifications, features, and Plans for the Building, construction drawings, and all other requirements of this IFB; (ii) in all other respects conform to the limitations of the Grant and Site Plan; and (iii) otherwise meet or exceed every other requirement of this IFB."
3. The County will not and does not "pre-approve" any proposed equal to be used by a Contractor under Section 24 of the County's General Terms, Conditions and Instructions to Bidders and Contractors. The County will evaluate any proposed equal when it reviews the solicitation responses after the due date for responses.

4. The County will not and does not "pre-approve" "Optional Alternate" plans proposed by a Contractor. The County will evaluate any "Optional Alternate" when it reviews the solicitation responses after the due date for responses.

Note: A signed acknowledgment of this addendum must be received at the location indicated on the IFB either prior to the bid due date and hour or attached to your bid. Signature on this addendum does not substitute for your signature on the original bid document. The original bid document must be signed.
