John called the meeting to order.

Ben Powell gave an update on Burn Building Training Facility. The team will meet with County Procurement Officer on May 10th for bidding options, grant requirements, etc.

Shelli Campbell was introduced as Burn Building Fundraiser Chair. FRA had to decide on color of bricks, fonts, set up accounts for vendor payment (Ms Campbell will talk with Finance Dept for 501C non-profit), cost for bricks for wall; such as 4x8=\$100, 8x8=\$250, or 12x12=\$500).

Future fundraising events: golf tournament, poker-run; chili cook-off, any other ideas get with Shelli.

Round Table discussions:

Fluvanna Rescue – Crystal – lights completed at Palmyra Rescue.

Fork Union Fire-Tre' –Engine 20 repairs cost approx \$2,800. Car 21 at Clear

Lake Rescue-Joe –Schools doors should be numbered so rescue can get in easier. Mike Brent stated this has been done and he will get the sheets to rescue & fire.

Lake Fire-Ritchie – New officers at Lake, getting a rural water supply class, Lake training 2nd & 4th Tuesdays. Recruitment & Retention Committee hasn't met yet. Had carbon monoxide poison at Lake Result from a heating system installed.

Fluvanna Fire Chief-Mike reported MJ on divert. Scottsville going paid next year – once they go full time will not respond in Fluvanna. We need to check County contribution to them.

Debbie Smith-Emergency Management Coordinator gave reports: \$4 for Life 50/50 calls
Cost of Map books to be printed \$100 piece – haven't been done in 6 years.

E911 signs-citizens must pay \$50 for replacement. Steve will talk with Eric Dahl about the vertical blue signs. Asking fire to help with Lift Assist tones.

Vehicle maintenance contracts on vehicles-have 4 suppliers: Atlantic, Colonial, *Goodman*,

And Joe's repair Service –KS fire uses for preventative maintenance-he will come to building. Fire Program-Hazardous Material Operation course. Ritchie asked that the course start before standards change as of July 1st. Andrew asked for a consolidated county training class.

- John asked that we review Mutual Aid agreement Fluvanna & Buckingham and we need to refresh and update the By-Laws.
- Complaint by Andrew Pullen-Call in K.S. April 1, 2018 –concerns no rescue truck in KS. He stated there are firefighters interesting in being able to run a truck. Applications were given out to become associate members.
