Department Reports & Updates:

Tre-FU Fire – Their request in the CIP request was pushed back.

Crystal-Fluvanna Rescue – Diesel fuel put in rescue trucks at Carysbrook was dirty. Truck #48 had to go to Colonial – Had dirty fuel filter service call cost \$900. She was told to talk with School System and they can talk to fuel provider. Had 2 clean-up at KS Station 3 and a rescue truck will be housed there within the week. Parking Lot has been paved at KS Station 3 by AE Fox Paving. The HVAC unit will be replaced at KS station 3. Devin did a CPR class on August 31st for fire & rescue personnel.

Emergency Management Coordinator-Debbie Smith - Daily meetings will be held at 10:00 AM in preparations for Hurricane Florence. The Community Service Day set for Sept. 15th has been cancelled due to the up-coming of Hurricane Florence. She went over the Pipeline training, paradigm set for Sept. 20th and Colonial Pipeline dinner at Palmyra Firehouse on Oct. 3rd at 6:00. New Rescue providers DRT will start Oct. 1st. A meet and greet breakfast is set for Sat Sept. 29th from 8:-11 at County Office building. Oct. 17th 4:00 CIP Budget work session with Board of Supervisors is set.
